THE COLLECTION

The Library has a very diverse collection of judgments, law reports, monographs, statutes, International Labour Organization (ILO) reports, periodicals, information files, speeches and electronic resources on industrial relations, employment, trade unions, management, economics and other peripheral subjects. The South branch of the Library has a Collective Agreement collection covering 2004–2016.

The Judgment collection consists of all judgments delivered at the Industrial Court since 1965 as well as the relevant Court of Appeal / High Court/Privy Council judgment.

The monographs are classified according to the Universal Decimal Classification (UDC) scheme. Periodicals/journals and Law Reports are arranged in strictly alphabetical order.
