

The Bulletin seeks to review developments in the country's labour market against the backdrop of the current economic environment. This is the Court's third publication of the Bulletin, providing useful analyses to stakeholders and the wider working population on various statistics derived from the database of the Industrial Court.

The data and analyses in this Bulletin covers the period 2012 to 2016 together with a snapshot of the first two quarters of the fiscal year 2016-2017. The fiscal year is from October of one year to the end of September the following year.

This Bulletin introduces a new table with the number of collective agreements sent for registration by the Ministry of Labour and Small Enterprise Development.

Through this publication, the Court hopes to review and develop new data sets on trends in the labour market which we think would be useful for stakeholders. In this regard, the Court continues to welcome suggestions from stakeholders and from the public in general to enhance the usefulness of the information in our Bulletin.



The domestic economy contracted further in 2016 as economic activity declined by 2.3% from -0.6% in 2015. The Central Bank's Index of Quarterly Gross Domestic Product (QGDP) revealed weakened economic activity in both the energy and non-energy sectors of the domestic economy. Depressed commodity prices and downtime for the maintenance of equipment by key energy companies have affected investment in the sector as well as oil exploration and production. The performance of the non-energy sector was also subdued with activity, contracting in *Distribution, Construction* and *Manufacturing* subsectors.

Notwithstanding increased fuel prices and the widening of the Value Added Tax (VAT) base in April 2016, the current depressed economic environment contained inflation in 2016. Headline inflation measured 3.1% in 2016 from 1.5% in 2015. The fiscal position also worsened in 2016 given the lower energy revenues as the overall fiscal deficit widened to TT\$ 7.3 billion (5% of GDP), compared with TT\$ 2.7 billion (1.8% of GDP) in fiscal year (FY) 2014/15.

During 2016, slower foreign currency inflows due to the lacklustre performance of the energy sector, saw the Country's net official reserves falling to US\$ 9,465.8 million or 10.5 months import cover from US\$ 9,933 million or 11.2 months import cover in 2015. At the end 2016, the weighted average TT\$/US\$ selling rate stood at TT\$ 6.6715 which represented a depreciation of 4.6% from the beginning of 2016.





Amidst depressed economic conditions in the domestic environment, the unemployment rate increased to 3.8% in the second quarter of 2016 from 3.4% in 2015. The preliminary estimates from the Central Statistical Office of Trinidad and Tobago (CSO) revealed a small increase in the non-institutional population to 1,067.3 thousand persons. There were 5,500 less persons with jobs in the second quarter of 2016 compared with 2015 and the number of persons classified as unemployed grew by 10% to 24,100 persons at the end of June 2016. Triggered mainly by lower productivity in the Assembly Type Related Industries, productivity declined in the second quarter of 2016 by 5.4% compared with the decline of 1.4% in 2015.



#### **OVERVIEW OF MATTERS**

For the Fiscal Year (FY) 2015/16 (Oct. 2015 – Sept. 2016), a total of 1,191 matters were filed at the both Registries, at the North (which includes matters from Tobago) and South locations of the Court. This represents 66% more than the matters filed in the corresponding period in 2014/15 (Oct. 2014 – Sept. 2015). This sharp increase is undoubtedly a reflection of the economy contracting and the volatile industrial relations climate in the country. Over the same period, 1,040 matters were disposed of, 340 more than in 2014/15 (Oct. 2014 – Sept. 2015); this resulted in an estimated disposal rate of 87%.


For the first two quarters of 2016/17 (Oct. 2016 – March 2017), 600 matters were filed at the Court, representing just over 50% of the total number of matters filed for the FY 2015/16 (Oct. 2015 – Sept. 2016). Meanwhile preliminary data reveal that already for the first six-month of the FY 2016/17 (Oct. 2016 – Mar. 2017), 490 matters have been disposed, representing a 81.7% disposal rate.






During the first six months of the FY 2016/17 (Sept. 2016 – Mar. 2017), the North branch of the Court registered a total of 529 new matters and disposed of 448 matters. Over the same period, 72 new matters were registered in the South branch, while 42 matters were disposed.

In the four-year period 2012/13 (Sept. 2012 – Oct. 2013) to 2015/16 (Sept. 2015 – Oct. 2016), a total of 3,436 and 501 matters were filed at the North and South Registries of the Court, respectively. Meanwhile for the same four-year period, the North Branch of the Court disposed of 2,938 matters, while the South Branch of the Court disposed of 357 matters. Consequently, the estimated disposal rates over the four year period are estimated at 86% for the North branch and 71.3% for South branch.

#### **MATTERS FILED**

Of the 3,932 matters filed at the Court during the four-year review period, 3,516 were filed in the General Services Division (GSD) while 416 matters were filed in the Essential Services Division (ESD). Of these 3,416 GSD matters, 87.7% were Trade Disputes (TD), while Retrenchment and Severance Benefits Disputes (RSBD) and Industrial Relations Offences (IRO) accounted for 4.4% and 3.5%, respectively. In the ESD, for the same period, Disputes (D) accounted for 60.3%, matters before the





During the FY 2015/16 (Sept. 2015 – Oct. 2016), 483 more matters were filed in the GSD compared to FY 2014/15 (Sept. 2014 – Oct. 2015). Among the matters filed in this division, Trade Disputes increased by 73% to 951 matters, while there were 63 more filings of RSBD matters and 18 more filings in Other Matters (maternity protection, minimum wages and rescission of contract, among others.).

For the first two quarters of 2016/17, preliminary data revealed that a total of 546 matters have been filed in the GSD while 55 matters have been filed in the ESD. Trade Disputes accounted for 80.2% of the matters filed in the GSD while Disputes accounted for 49% in the ESD. Notably for the first six months of FY 2016/17, 31 OSHA matters have already been filed in the GSD compared with 30 such matters for the entire FY 2015/16.

#### **MATTERS DISPOSED**

Of the 3,295 matters disposed of by the Court over the four-year review period, 40.8% (1,344 matters) were dismissed or withdrawn, while 25.6% (845 matters) were disposed of by judgments. A further 18.4% of the matters (605) and 15.2% of the matters (501) were disposed of through bilateral discussions and conciliation respectively.

The increasing number of matters disposed by dismissals/withdrawals and the growing percentage of disposals by conciliation and bilateral method, are indicative of the fact that parties have accepted and embraced the Court's approach, which is, that amicable settlements should be the first approach in the resolution of disputes wherever possible before resorting to open court hearing.



#### **INDUSTRIAL COURT STATISTICS**

For the FY 2015/16 (Oct. 2015 – Sept. 2016), of the 1,040 matters disposed by the Court, 45.6% were dismissals/withdrawals and 26.3% were through judgments. Data for the first six months of FY 2016/17 (Oct. 2016 – Mar. 2017), revealed that of the 490 matters disposed by the Court, 41.2% (202 matters) were either withdrawn or dismissed. Meanwhile disposals through judgments / rulings, bilateral agreements and conciliation accounted for 21.6%, 18.6% and 13.5%, respectively of the total matters disposed by the Court in the first six months of FY 2016/17.

#### **TRADE DISPUTES**

During the period 2012/13 to 2015/16 (Oct. 2012 – Sept. 2016), the Court received 3,083 new Trade Disputes. Of these disputes, 60.5% of the matters (1,864) were related to dismissal/termination of employment, while others were related to suspensions (219 matters), failure to pay wages (167 matters) and failure to pay other benefits such as sick leave, injury leave and overtime (117 matters).





In FY 2015/16 (Oct. 2015 – Sept. 2016), there was a marked increase of over 70% in the number of trade disputes filed related to dismissal/termination of employment when compared to FY 2014/15 (Oct. 2014 – Sept. 2015). In the first two quarters of FY 2016/17 (Oct. 2016 – Mar. 2017), 437 trade disputes were received by the Court, 65% of which dealt with grievances related to dismissal/termination of employment. Moreover, consistent with the prevailing industrial relations climate, the Court received 5 trade disputes arising from layoffs compared to FY 2015/16 (Oct. 2015 – Sept. 2016), where there were only 3 such disputes.

#### **BREAKDOWN IN NEGOTIATIONS**


For the period 2012/13 (Oct. 2012 – Sept. 2013) to 2015/16 (Oct. 2015 – Sept. 2016), the Court received 71 new trade disputes in the General Services Division with respect to the Breakdown in Negotiations between Unions and Companies. These 71 disputes are 2.3% of the total number of trade disputes filed. Of this, 58 disputes were received at the North branch of the Court, with the highest number (27 matters) being recorded in the year 2013/14 (Oct 2013 – Sept. 2014).

During 2015/16 (Oct. 2015 – Sept. 2016), there was a 35% decline in the number of Breakdown in Negotiations filed at the Court (North and South) compared to 2014/15 (Oct. 2014 – Sept. 2015). However, preliminary data for the first two quarters of 2016/17 (Oct. 2016 – Mar. 2017) showed a sharp increase, since already for this six-month period, there have been 17 disputes filed arising out of the Breakdown in Negotiations, 10 more disputes when compared to the FY 2015/16 (Oct. 2015 – Sept. 2016).


#### **COLLECTIVE AGREEMENTS**

During the period 2012 - March 2017, the Court received from the Ministry of Labour and Small Enterprise Development 403 Collective Agreements for registration – 350 under the General Services Division, 19 under the Essential Services Division and 34 under the Special Tribunal.

#### **WAGE INCREASES**

In 2015, wage increases ranged from 5% to 26%, the highest over the period 2013 - 2015. The *Distribution* Sub-Sector accounted for the wage increase of 26% for the bargaining period 2011- 2013. In 2014, increases in wages ranged from 0% to 19%, with the highest increase of 19% emanating from the *Finance, Insurance, Real Estate* and *Business Services* Sub-Sector, for the bargaining period 2010 - 2012.

Meanwhile in 2013, wage increases ranged from 5% to 20% with the highest increase of 20% coming from the Assembly Type and Related Industries for the bargaining period spanning 2013 - 2016.

On the other hand, for the review period 2013 to 2015, the lowest wage increases were recorded in the (a) *Transport, Communication & Storage*, (b) *Finance, Insurance, Real Estate & Business Services*, and (c) *Personal Services* sub-sectors respectively.

In addition, for the period under review, the modal increase of negotiated wages fluctuated from 15% in 2013 to 9% in 2014 while increasing slightly to 12% in 2015.
