The ILO celebrates **World Day for Safety and Health at Work** annually on the **28 April** to promote the prevention of occupational accidents and diseases globally. It is an awareness-raising campaign intended to focus international attention on emerging trends in the field of occupational safety and health and on the magnitude of work-related injuries, diseases and fatalities worldwide.

## 2019 theme: Safety and Health and the Future of Work

This year marks **100 years** of promoting and celebrating Safety and Health in at Work. Worldwide events and activities begin on 28 April and continue throughout the rest of the year, celebrating and building on the wealth of knowledge and action accumulated over 100 years as we get ready to face and appreciate the changes in culture brought forward by the future of work we want. A national occupational safety and health culture is one in which the right to a safe and healthy working environment is respected at all levels, where governments, employers and workers actively participate in securing a safe and healthy working environment through a system of defined rights, responsibilities and duties, and where the highest priority is accorded to the principle of prevention.

Occupational safety and health (OSH) can be important for moral, legal, and financial reasons. All organisations have a duty of care to ensure that employees and any other person who may be affected by the companies undertaking remain safe at all times. Moral obligations would involve the protection of employee's lives and health. Legal reasons for OSH practices relate to the preventative, punitive and compensatory effects of laws that protect worker's safety and health.
