The United Nations' (UN) World Day of Social Justice is annually observed on February 20<sup>th</sup> to encourage people to look at how social justice affects poverty eradication. It also focuses on the goal of achieving full employment and support for social integration.

The Industrial Court has set as its vision:

"To be an Industrial Court established under the Constitution which is fair, equitable and expeditious in dispensing **social justice**."

Social justice is an underlying principle for peaceful and prosperous coexistence within and among nations. We uphold the principles of social justice when we promote gender equality or the rights of indigenous peoples and migrants. We advance social justice when we remove barriers that people face because of gender, age, race, ethnicity, religion, culture or disability (*UN*, *World Day of Social Justice [on-line]*, 2018).
